**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
UNIVERSITAS INDONESIA, REPUBLIC OF INDONESIA  
AND  
THE FUTURE UNIVERSITY, SUDAN**

**No: 11/MOU/R/UI/2014**

**Universitas Indonesia** an Institution of higher learning which was stated as university that organized by government based on government regulation No.68 year 2013, domiciled at Jl. Salemba Raya 4, Jakarta. In this matter represented by Prof. Dr. Ir. Muhammad Anis, M.Met in his capacity as Acting Rector pursuant to Decision of the Board of Trustees of Universitas Indonesia No.003/SK/MWA-UI/2013 stipulated on 03 May 2013 and now therefore lawfully act for and on behalf of Universitas Indonesia (hereinafter referred to as "UI").

and

**The Future University**, domiciled at Africa Street, Khartoum, P.O. BOX 10553 Kartoum, Sudan. In this matter represented by Dr. Abu Baker Mustafa in his capacity as Chairman of the Board of Trustee, and therefore lawfully acting for and on behalf of **The Future University** (hereinafter referred to as "FU"), collectively referred to hereinafter as the "**Parties**" and individually as the "**Party**".

**WHEREAS:**

1. The Universities agree to enter into agreement;
2. The Universities recognize that the academic cooperation will promote further educational collaboration and cultural understanding and have agreed to further continue their common interest in promoting the mutual cooperation in the area of education and research;
3. Nothing in this MOU is intended to create a commitment of financial resources or legal relationship between the two signatories; and
4. The Universities agree to implement the MOU under the terms and condition hereinafter set forth.

**NOW, THEREFORE**, for and in consideration of their mutual promises and undertakings, the Universities agree as follows:

**ARTICLE 1  
PURPOSE AND OBJECTIVE**

- (1) The purpose of this MOU is to make possible and to facilitate the exchange of students, scholars and educational resources between Universities, based upon principles of mutual equality and the reciprocity of benefits.
- (2) The objective of this MOU is to strengthen ties between Universities and to promote academic cooperation and to further cultural understanding in both countries.

**ARTICLE 2  
SCOPE OF ACTIVITIES**

The scope of activities of the MOU shall include:

**A. ACADEMIC STAFF PROGRAM**

- (1) Visit by academic staff will be encouraged for the mutual benefit of Universities. Each University will accept faculty members and researchers from the other University. Suitable arrangements will be made for the exchange of visiting scholars for collaboration in teaching and in research in case by case basis;
- (2) The host university will provide the normal services for visiting scholars including access to laboratory facilities;
- (3) The host university will assist, as far as possible, in arranging accommodation for the visiting scholar, and will assist the visiting scholar in matters of immigration, stay and working permit, medical emergencies, language and local custom.

**B. JOINT RESEARCH PROGRAM**

- (1) The Universities will seek opportunities to cooperate in research. The details of specific research proposals will be determined by the mutual agreement of relevant faculties of Universities;
- (2) Any Intellectual Property Rights resulted from the cooperation will be discussed and arranged in separate agreement.

**C. CULTURAL EXCHANGE PROGRAM**

- (1) To facilitate academic and cultural exchange, the exchange of research materials, publications and information will be encouraged;
- (2) Each university will invite the other, when appropriate, to participate in conferences, workshop, symposia and short visits. Joint educational programs and joint curriculum development are encouraged as well.

**D. STUDENT PROGRAM**

The student exchange program will be detailed in a separate agreement. Other activities under the student program may include short-term faculty-level programs, joint degrees and courses, and the provision of library access and academic assistance for students. Such activities shall be negotiated and agreed to by Universities on a case-by-case basis.

**F. OTHER ACADEMIC EXCHANGE TO WHICH UNIVERSITIES AGREE**

Before these activities are implemented, Universities shall discuss each activity involved to the satisfaction of each University and enter into a specific agreement identifying the responsibility of each University.

**ARTICLE 3  
FORCE MAJEURE**

No Party shall be liable for any delay or failure in the performance of any of its obligations under this Agreement to the extent that such delay or failure is caused by Force Majeure, provided that, the Party whose performance is prevented or delayed by such Force Majeure shall make every good faith effort to overcome or dispel the event of Force Majeure.

**ARTICLE 4**  
**AMENDMENTS, EFFECTIVE DATE, DURATION, AND TERMINATION**

- (1) This MOU can be amended by mutual consent of the Universities. Any amendments to this MOU can only be made in writing and after consultation and mutual consent of the Universities. Such amendments, once approved by the Universities, will become part of this MOU.
- (2) The effective date of this MOU shall be latter date on which the Universities sign this MOU.
- (3) This MOU shall remain in force for a period of 5 (five) years from the date of the latter signature. The MOU may be extended by written mutual consent of the Universities.
- (4) The MOU may be terminated by either University by giving written notice at least 6 (six) months in advance to the other University. The event of termination will not affect participants from completing their activities at the host University.
- (5) Universities jointly follow up this MOU in the form of Cooperation Agreement made no later than 6 (six) months after the signing of this MOU.
- (6) In case the MOU ceases to be effective on the account of termination or expiration, the provisions of all valid agreements signed as addenda to this MOU shall continue to apply to the extent necessary to secure the implementation of existing activities as agreed upon in the Plan of Operation documents.

**ARTICLE 5**

Any notice or request given or made by one University to the other under this MOU shall be in writing in the language of English and shall be addressed to the appropriate office as is designated in writing hereinafter:


